III, Pharmacist Gr. III, Radiographer and Lab Assistant Gr. II against CEN No. 02/2019, the candidates with the following roll numbers have been provisionally empanelled and their names are being forwarded to Principal Chief Personnel Officer, N. F. Railway, Maligaon, Guwahati. Further course of action on their appointment will be taken from the office of Principal Chief Personnel Officer, N. F. F. Railway, Maligaon, Guwahati. All candidates will be required to submit an affidavit that their Degree certificates and caste certificates, as the case may be, are genuine and valid.
